

## **CHAPTER-III** **(GRANTS)**

**0301.** The details of financial assistance admissible as Grants to serving CG personnel are given in the succeeding paragraphs.

### **Spastic and Physically Impaired Children**

**0302.** Parents of Spastics / Mentally Retarded / Physically impaired children are eligible for 100% reimbursement of expenses incurred towards study up to Graduation level for the following :-

- (a) Tuition fees paid by the parents for studies in special schools catering for such children (Tuition Fees Receipt in original are to be forwarded along with the applications).
- (b) Purchase of special equipments and its repairs subsequently (Original Bill / Bills to be forwarded along with the applications).
- (c) Conveyance charges to & fro the Special Educational Institute (Transport receipt / bus cards to be attached to the application).
- (d) Hostel charges (Institute's Bill required to be attached along with the applications).
- (e) A consolidated statement showing various expenses under separate heads viz. Tuition Fees, Conveyance, Purchase of Special Equipment, Hostel Charges supported by the original receipts duly authenticated by the Head of the Institute and medical documents / progress certificate as follows must accompany the applications : -
  - (i) **Initial Claim.** The medical documents / certificate issued by the concerned hospital / authorised medical attendant.
  - (ii) **Subsequent Claim.** Progress certificate and photo copy of the original medical documents / certificate.
- (f) The reimbursement may be claimed half yearly or yearly.

**Note:-** This grant would not be given in case the handicapped / impaired child is studying in normal / general educational institute. In those cases, re-imburement of Tuition Fee would be admissible @ Rs.100 p.m. as per Govt. of India, Min of Defence, letter No.21017/197-Estt (Allowances dated 12 Jun 1998.

### **Ex-Gratia Grant to NOK on Death**

**0303.** Ex-Gratia Grant to the NOK of officers and enrolled personnel who die whilst in the service, are sanctioned at the following rates: -

<b><u>Sl. No.</u></b>	<b><u>Type of Grant</u></b>	<b><u>Officers</u></b>	<b><u>Enrolled Personnel</u></b>
(a)	Widows of Coast Guard Personnel	Rs. 60,000	Rs. 50,000
(b)	NOKs of unmarried Coast Guard Personnel	Rs. 50,000	Rs. 40,000

**0304.** The Regional Commanders are delegated the authority to make on the spot payment from the Regional Non-Public Fund not exceeding above limits to NOK of the deceased personnel on receipt of the information from the concerned Commanding Officers. All the relevant documents / Application forms / details of payments made are to be forwarded to the Secretary, CGBA, CGHQ, New Delhi immediately after payment. This amount will be reimbursed by the Coast Guard Benevolent Association later.
